Accessibility: It's the Law!

Accessibility is important to your business and to people with disabilities. But because there are several laws that require and enforce accessibility, it can be confusing and overwhelming to the general layperson.

One of the many laws currently on the books is Title III of the Americans with Disabilities Act (ADA) of 1990. Title III requires public accommodations to provide goods and services to people with disabilities on an equal basis with the rest of the population.

What is an Accessibility Survey?

An Accessibility Survey is a simple tool used to determine if your business is accessible to all persons, regardless of disability.
