JACIL offers Circuit Breaker Workshop

The Illinois Department on Aging's Circuit Breaker program provides grants to senior citizens and persons with disabilities to help them reduce the impact of taxes and prescription medications on their lives.

When the costs of property taxes and prescription medicines begin to "overload" our seniors and persons with disabilities, this program steps in to help, just as a circuit breaker prevents overloads in an electrical system. The program also assists individuals with a discount in license plates.

NOTICE: In past years, the Department on Aging has been able to issue Circuit Breaker grants at the maximum allowable amounts. However, the state budget for fiscal year 2010 (July 1, 2009 - June 30, 2010) did not fund the Circuit Breaker program at those levels.

In order to continue to provide the Circuit Breaker grant benefit to older adults and persons with disabilities on and after July 1, the Department made the difficult decision to cut each grant awarded in half. This decision based on budgetary cutbacks cannot be appealed.

Also, the Circuit Breaker Program assists with medications for any one over 65 years old and people with disabilities ages 16 to 64 who meet the income guidelines.

JACIL staff will begin taking appointments to

assist consumers in completing online or paper applications on February 10, 2011.

To help individuals file their Circuit Breaker forms this year, JACIL has set aside Thursday February 10 from noon to 3:00 p.m. in the Jacksonville office. You are encouraged to call 217-245-8371 for an appointment.

Derrick, Mary, Susan and Paul will be assisting individuals during that time, and an interpreter will also be available from 12:30 - 2:00.

A look at accessibility vs. inclusion

My interest was recently piqued by an article in the January 2011 issue of *New Mobility*. My thanks to Scott Rains for his article "Accessibility is NOT Inclusion";

People with disabilities deal every day with access issues. We celebrate the Americans with Disabilities Act because it made access a right - curb cuts, ramps, restrooms, communication, etc. But accessibility looks at things - and gives specifics (minimum standards, by the way) for how wide, how high and where, etc.

Inclusion, on the other hand, focuses on the <u>person</u>. In his article, Rains compares "inclusion" to hospitality. Inclusion looks past the physical barriers which are the focus of accessibility. Inclusion strives for participation, and draws people in, welcoming them to be a part of the action. Inclu-

sion requires active involvement of all.

Accessibility assures that the door is open; inclusion welcomes people in the door to participate in the social fabric of our world. In spite of accessibility, when people are not welcomed into the human network, the result is "exclusion".

Scott Rains opens his article with a question: "What if the first question we asked was 'what is so unique about this situation that it justifies exclusion?" That question should be the crux of decision-making rather than the cost of access.

JACIL's mission statement asserts we are committed to "maximum independence and community participation", including the home, workplace and community. Inclusion is important to JACIL. Come our office to see a copy of Mr. Rains' full article.

JACIL's Legislative & Voter Advocate Cyndy Benton recently reported on the successful efforts by our staff and supporters in making legislative contacts from October 1, 2009, to September 30, 2010.


"In all there were nearly 900 contacts made to our

elected officials during the reporting year," Cyndy said. "Just over 87% of the contacts were made with officials from the state of Illinois. About 11% were advocacy efforts with federal officials and two percent were local contacts.

"These communications included telephone calls, letters sent by mail, e-mailed messages and attendance at various political rallies," Cyndy said. "it was an amazing effort by our people and helped influence some great decisions made in Washing, Springfield and on the local front."
