

What is a CIL?

CIL stands for Center for Independent Living. Each CIL in Illinois designs its services for the specific counties it serves. Each CIL is mandated to provide at least four core services:

1. Information and Referral

Requests for information range from quick and easy to detailed and involved. A large volume of calls received by a CIL are from individuals beginning their search for information about available programs which serve their specific needs. A CIL avoids duplicating services offered by other area agencies and provides referrals to these organizations. A CIL works to meet unmet needs in the regions they serve.

2. Independent Living Skills Training

A CIL helps consumers acquire the skills they need to meet their goals for living independently in the community.

3. Individual & Systems Advocacy

A CIL informs consumers of their rights as citizens with disabilities and works to make certain their rights are respected. A CIL is even involved in legislative issues related to disabilities to help insure those rights are maintained.

4. Peer Mentoring

A CIL offers support to individuals with disabilities. This can be achieved through CIL sponsored support groups or by utilizing existing facilities in the community. One-on-one peer counseling is also provided.

About



JACIL is part of a grassroots movement directed toward independence and the social change of individuals with disabilities. Due to federal mandates, the majority of the staff and board of directors are required to be persons with disabilities.

JACIL first opened its doors in 1997 and in 2000 started a satellite office in Mason County with a full time staff person located there.
